- 1. In these Terms and Conditions:
 - Rainbow Meats means employees, agents, contractors, officers and related bodies corporate (as that term is defined in the Corporations Act 2001 (Cth).

 - Rainbow Meats, Shop 2557 Highpoint Shopping Centre, 120-200 Rosamond Road, Maribyrnong 3032.

Card means the Rainbow Meats LOYALTY CARD card issued in accordance with these Terms and Conditions.

Cardholder means a person who has applied for a Card and whose application has been accepted by Rainbow Meats.

Programme means the LOYALTY CARD Member Rewards Programme run by Rainbow Meats.

- By applying for the Card the applicant agrees to be bound by these Terms and Conditions and any variations to them; agrees to participate in the Programme; and agrees to receive information and promotions via e-mail, and SMS/MMS (where such information has been provided by the Cardholder).
- 3. To apply for a Card and become a Loyalty Cardholder, the person must:
 - Visit a Rainbow Meats store and register their name, email address and post code.
- 4. Rainbow Meats may, in its absolute discretion and without giving reasons for its decision, accept or refuse an application for a Card.
- 5. Cardholder benefits are determined by Rainbow Meats from time to time and may include discounts for products purchased at participating Rainbow Meats stores.
- 6. The rights &/or benefits of a Cardholder are non-transferable and not redeemable for cash.

- 9. All discounts for Cardholders for purchases at Rainbow Meats stores are subject to availability.
- 10. A Cardholder must produce their Card if seeking the benefit of any discount or other benefit offered to Cardholders or upon request by Rainbow Meats.
- 11. Rainbow Meats does not warrant in any way that the discounts or benefits for Cardholders will be available at any particular time or times or in any particular stores.
- 12. Cardholder benefits are valid until terminated or cancelled by Rainbow Meats (in its absolute discretion) or until the Cardholder notifies Rainbow Meats customer service on 9874 5496 that he or she wishes to terminate their Card. If a Card is terminated the Cardholder must return the Card by hand to a Rainbow Meats store.
- 13. Rainbow Meats is not responsible for stolen or lost Cards or Cards that are used fraudulently. The Cardholder must report a stolen or lost Card to Rainbow Meats immediately. The Cardholder's existing Card will be cancelled and a new Card issued. A fee of \$2 will be charged.
- 14. To the fullest extent permitted by law, Rainbow Meats gives no warranty and shall have no liability in respect of goods or services provided to Cardholders or as to the accuracy of any description or information about such goods or services, even though Rainbow Meats may have notified the Cardholder of those goods or services.
- 15. Rainbow Meats makes no warranty or representation as to the quality, suitability or merchantability of any goods or services offered as prizes.
- 16. Cardholders indemnify Rainbow Meats for and against any loss or claim suffered or incurred by Rainbow Meats arising from or in connection with a breach of these Terms and Conditions by a Cardholder.
- 17. Cardholder can access his or her personal information held by Rainbow Meats by logging onto our website, entering their personal pin number and or by accessing the in store kiosks.

 - suspend or terminate the Card at any time and without prior notice; and
 - vary these Terms and Conditions at any time for any reason and without notice to Cardholders.
- 19. For the avoidance of doubt, these Terms and Conditions supersede and replace any and all previous Terms and Conditions specifically governing the Programme.
